New Grants avenues is being looked into with 'Play Area Network' previous Clerc R.lewis received e-mail as was still on the list and forwarded.

#### **URGENT**

Clerc received a notice for Outstanding Accounts stating that the annual returns for the financial years;

18/19 19/20 20/21 21/22 22/23 had not been received to comply with Audit.

22/23 is being resolved with the accountant, which is required by 01/02/2024, however, the Clerc had to cancel the appt on Monday the 8th, the re-arranged for Friday 19th as the statements have not been received. Appt with the accountant Weds the 24th is now in place, however, Clerc is concerned there seems to be no urgency from Cllr. R. Pugh and the previous Clerc R.Lewis surrounding the severity of the outstanding accounts which is now with the Audit Manager Investigative Studies Team and what is required to be handed over for those years.

The Clerc is unable to comply with all requests due to not being on the mandate and the fact there was no full handover with no sight of some of the requested documents.

This requires the full cooperation of Cllr.R.Pugh, and he requires urgently to communicate with the previous Clerc and Chairperson to resolve.

Cllr.M.chambers is being fully supportive and helping Cllr.R.Pugh out but again due to not being on the mandate this is making it extremely difficult.

HSBC we are still in dispute over a missed surname of 'Pugh' even though the individual remains on the mandate, and again HSBC stated that R.Lewis requires online access which would resolve the mandate issues immediately.

The Clerc wants it noted that all current Cllrs must attend as a minimum the 'financial training' course at the earliest possible in 24 and will be collating dates to attend these training sessions.
